("SUBNET") warrants to You (the customer who has obtained a license from SUBNET to use a signature image (namely, the original, SUBNET supplied image of the Software delivered to you or the party from which you have acquired the applicable software) of its software (the "Software")) that, subject to the terms of your license with SUBNET for such Software, such Software shall be free from errors that result in a failure to execute programming instructions for five (5) years from the release date for such Software. This warranty is conditioned upon your strict compliance with the terms of your license to use the Software, the proper installation, operation and maintenance by You of the Software (and the hardware and production environment in which it operates), prompt written notice to SUBNET of any errors and, if required, prompt availability of the Software (and the hardware and production environment in which it operates) to SUBNET for analysis, testing and correction.

This warranty shall be void in its entirety if: You fail to implement any required fixes, patches or upgrades to the Software as may be made available by SUBNET from time to time; You modify the Software (or the hardware or production environment in which it operates); You use the Software for any purpose or application not specifically permitted under the terms of the License; You fail to strictly comply with the terms of your license; or Your license to use the Software is terminated. If the Software fails to conform to this warranty, You properly notify SUBNET of such failure and You make the Software (and the hardware and production environment in which it operates) available to SUBNET for diagnosis (and pay all expenses related to same), SUBNET shall correct any such failure by, at its sole discretion, either repairing or replacing the Software; including, by making available to You (including, via ftp download site) any necessary fixes, patches or upgrades to the Software. Software fixes, patches or upgrades shall be covered by this warranty for the longer of one (1) year from date they were made available to You or the remainder of the original warranty period.

SUBNET shall use reasonable efforts to pass the original manufacturer warranty on to You for non-SUBNET products or software. SUBNET does not warrant non-SUBNET products or software, or products or software prototypes provided by SUBNET for testing or marketing purposes.
